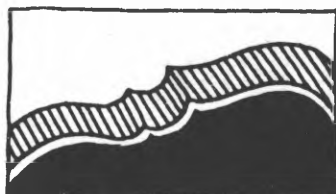

## Roy Bookbinder to Perform May 13th



FSGW's monthly program for May, to be held Friday, May 13, will feature blues and ragtime musician Roy Bookbinder. Roy has earned a reputation as one of the best blues and ragtime musicians in the country. In his college days, he studied guitar with the great Rev. Gary Davis. He later met, studied with, and toured with Pink Anderson. His performances clearly are not copies of the masters, but in his own unique style he shows great respect for the heritage from which he draws his material. A touring musician for over 10 years, Bookbinder lives in a mobile home and stays on the road most of the year. Britain's Melody Maker magazine has called him "entertaining, colorful, charismatic, absurdly gifted, and a virtuoso supreme." Roy can be heard on several records, including his latest on Flying Fish called Going Back to Tampa. He is in a class with

his early influences, as well as with other modern interpreters of the ragtime and country blues styles such as Leon Redbone and Geoff Mauldaur.

The concert begins at 8:30 p.m. on Friday, May 13, at the W.E.S. auditorium, 7750 16th St., N.W. (near Kalmia Rd.). Admission is free to FSGW members, and \$4.00 for nonmembers.

# Nominees for FSGW Office in 1983-84

The following statements have been submitted by candidates for office on the FSGW Board during 1983-84. (Candidates' statements are presented in alphabetical order within each position.) Please use this information to help you decide for whom you want to vote. A ballot is enclosed with this Newsletter. For your vote to be counted, it must be returned no later than May 15. Ballots may be returned by mail, or may be turned in at the FSGW program on Friday, May 13.

## President

Kathy Westra Hickerson: "As an FSGW member for seven years, and a member of the FSGW Board for the past four (two as Program Chairman and two as Publications Chairman), I've gained firsthand appreciation of the hard work it takes to run a volunteer society as large as ours. I believe my continuous experience on the Board these past four years is an important asset, since FSGW's programs don't stop every time new officers are elected, but rather build on the work of the previous year. As President of FSGW, I hope to help implement many of the good ideas developed by this year's Board in its discussions of FSGW's programs and purposes. I would like to involve more of FSGW's members as volunteers and active participants in the Society's many activities. FSGW is a strong, vital group with a fantastic array of programming. I would be proud to serve as its President."

Debbie Hutton: "I believe the FSGW should serve three main functions: 1) publicly presenting a wide variety of traditional folk arts; 2) being a visible resource about traditional folk arts for the community; and 3) actively promoting contact between members with similar interests through social events, workshops, educational programs and volunteer opportunities. I have actively encouraged these functions by initiating the Washington Folk Festival and Mini Festival. I have also served as Member at Large, Special Events Chairman, and am currently Vice President. In the future I would like to see the FSGW increase its activities for families and children, experiment with regional activities, strengthen the dance program for the general membership, continue interpretation for the deaf when appropriate. It is also important for the FSGW to increase its volunteer base. Our activities are limited only by lack of manpower. I enjoy talking to members and would enjoy serving as President of FSGW."

## Vice President

Dwain Winters: "It has been my pleasure over the past few years to serve the members of FSGW in several capacities. These include Member at Large, Publicity Chairman, and, for the past three years, member of the Washington Folk Festival Coordinating Committee. In these roles I feel that I have been able to make significant contributions in shaping the growth and progress of FSGW towards serving the needs of all of its members. There is of course much more to be done. The major challenge to the future of FSGW will be insuring that as FSGW grows (we are about to exceed 2,000 members), we continue to provide traditional dance, music, storytelling, and crafts with the same quality and on a scale in keeping with our past tradition. As your next Vice President, I would work to meet this challenge."

## Secretary

Dean Clamons: "I have served on the planning committees for the Getaway and the Washington Folk Festival for the last four years, and am currently a member of the Coordinating Committee for the Festival. I have also served one term on the FSGW Board as Member at Large. I'm a real fan of the Folklore Society. To me FSGW offers the best value in entertainment in the metropolitan area while providing a valuable service to the community by presenting and preserving folk traditions. I have enjoyed every FSGW event that I've been to in the last ten years, and I've enjoyed working with the people who have made these events possible. If you want to see FSGW continue to serve the folk community, vote for me; I'll do what I can to keep FSGW on its highly successful course."

Carol Lite: "My high school typing teacher wouldn't believe it--her slippery-fingered student running for Secretary! Fortunately, I've come a long way since then! Six years ago, I happened upon a surprisingly wonderful June weekend at Glen Echo, and I immediately joined FSGW. At first an active listener, I gradually worked through the ranks as vegetable-cutter, registrar, and song leader at Getaways; and promoter of membership, trash picker-upper, and food preparer at Mini and Washington Folk Festivals. I enjoyed the involvement and am now eager to be a member of the Board. If elected, I hope that members will feel free to call me with the thoughts and suggestions they'd like the Board to hear. I'd like to be able to give back some of the energy FSGW has given me."

## Treasurer

Dick Hamlet: "It took me from the late 1960s until 1981 to discover FSGW, but in two years I've run up a considerable moral debt to the Society for the high quality of its people and activities. I've tried to repay by volunteering to work, in particular as publicity chairman for last year's Washington Folk Festival, and by organizing volunteers for the Mini-Festival. The treasurer's job is one that involves a regular contribution to FSGW, which would please me. My qualifications: I balance my checkbook without difficulty, even without a calculator. I don't cheat on my income tax (although the bad example set by some past U.S. Presidents and Maryland Governors has helped keep me honest). I attend most FSGW events at which the treasurer door-sits, and I hope I can greet people as pleasantly as I've been greeted."

Bruce Olson: "I have been a fairly active member of FSGW for about the last five years, and am also a member of the American Folklore Society and the English Folk Song and Dance Society. I have published several notes on old songs in the latter's journal. More recently, I've been connected with performance of folksong, music, and dance, and will try, if elected, to do a good job as treasurer and to see that, as stated in the By-Laws of the Folklore Society, FSGW promotes and preserves our traditional arts. They are time-tested, and a solid heritage we can enjoy and trust."

## Publicity

Joanne C. Turner: "Publicity is one of the ways that the Society reaches out to the membership and the public. My 15 years as an FSGW member and two years as Secretary have impressed upon me the importance of good and timely publicity. During this past year, I also chaired the Future Directions committee, and am currently working on the Washington Folk Festival as Community Resources chair. I look forward to the opportunity to take on responsibility for the Society's

publicity, which has been handled so well by my predecessors."

## Publications

Jennifer Woods: "I have been very active in FSGW for the past three years, and currently serve on the Board as Member at Large. I have been co-registrar for the last Getaway, and was volunteer coordinator for last year's Washington Folk Festival, a post I am again filling this year. I also have been one of the coordinators for the monthly Sacred Harp Sings for the past two years. And, I have helped produce, stamp, address, and mail newsletters for the past year. As a graphic artist, I have produced a number of flyers and other promotional materials for FSGW, and my professional background will be an asset to the Publications Chairman duties."

## Program

Peter Kraemer: "Throughout the last year, under Cathy Fink's excellent stewardship, we have been fortunate to have a variety and scope of programs reflecting the diversity and broad interests of the Society, its members, and the community at large. It would be my goal, if elected, to continue in this fashion, and bring to the Society's programs an increasing degree of breadth and interest, while keeping up with old favorite and regular features which the Society has come to expect."

Linda Lieberman: "I have been an FSGW member since 1976. I have served as Treasurer from 1977-79, and as Past Treasurer in 1980. I was volunteer coordinator for the first two years of the Washington Folk Festival, and this year I am coordinating the performer and staff food. I was co-chair for the first two Mini-Festivals at George Mason University. I organized and ran the food operation for four Mini-Festivals and one Getaway. I chaired an FSGW Nominating Committee, and have served in other years on the program, dance, and finance committees. I feel that I am qualified to be the Program Chairman since I have served on several program committees, including this past year. I am very interested in presenting a variety of programs including some involving audience participation with singing and dancing. If elected by you, I promise programs that are interesting, amusing, informative, and diverse."

## Special Events

Bob Clayton: "I am an old FSGW hand and have held the position of Special Events Chairman before. I intend to keep the good balance and excellent level of talent that has been offered by this year's chair. I think of myself as reasonably well-balanced in my musical taste, and will not attempt to bias my offerings toward one type of music. To do this, I will need the aid of the membership in suggesting possible programs/events, since I can't be everywhere and hear everything. With your help, I can do it."

## Dance

Marilyn Lingard: "I've been country dancing since 1977, and am squire and bagman for the Rock Creek Morris Women. As Dance Chairman I'll try to find a wooden floor and put on dances that provide a variety of dance forms. I hope that along the way, we'll all learn to dance with style."

## Membership

Donald Nichols: "The qualifications which I believe I bring to the job of Membership Chair are those of long experience with the problems of the task, as the Society mailing list has grown from less than 600 people to in excess of 2100 people (many of whom are very mobile, requiring frequent updates of the records). The membership files are maintained on our home computer, which also has grown with the job. All programs used were written by me, and are designed to keep a human in control at all decision points. I hope to maintain the membership operation as smoothly running and as responsive as possible."

## At Large

Charlie Bryant: "Last year at this time I was running for Special Events Chairman. Everyone agreed that my brief campaign speech in this space was quite amusing; everyone also voted for my opponent. Realizing that this will not do two years in a row, I offer a few compelling reasons why I should be your Board Member at Large. I will not approach this job indifferently; I promise to put all the energy I can muster into representing the best interests of the Society and its members. I will attend meetings faithfully and do what I am told, unless I disagree; I will cheerfully dig in and do whatever horrid jobs need to be done. I have not held an FSGW office before, so this job should be an ideal opportunity for me to learn more about how the Society gets things done and to contribute to that process. With your votes, I will do it."

Paul Goland: "I have been an active member of FSGW for over a decade, and I have worked for the Society on many projects. I am running for the Board for the first time. During the coming year I want to work on the membership committee, prepare a really outstanding FSGW sampler concert, explore the potential for a FSGW music and craft fair, participate in budget formulation, and work at coordinating volunteer recruitment. Although I spend half my time in the hills of West Virginia, I will attend every Board meeting and complete all tasks I take on. I am a program analyst in workforce management for the National Weather Service. Organizing effort, recruiting talent, and maintaining employment information on 5000 people are key elements of my government job."

Kerry Johnson: "I will do my best to help promote the activities of the Society if elected. I have been a member for four years and am not yet a rutabaga."

Lois Bruckner Parks: "Many of you remember me as Lois Bruckner, but on May 16, 1982, I married a jazz musician, Dick Parks. I've been a member of FSGW since 1976, and have assisted the organization in a wide range of jobs including putting out the newsletter, leading open sings, volunteering at Getaways, and leading various Getaway workshops. I play autoharp, banjo, and piano, and perform and enjoy a wide variety of musical styles. I believe we should do more to encourage more of our membership to participate in the activities of FSGW. I also think it would be a good idea to have monthly or bimonthly jams at members' homes so that those of us who enjoy making music can get together more often. Beyond that, I promise to be accessible and open to all ideas of the membership. I further thank all those supporting my candidacy."

Jim Spirer: I have been a member of FSGW for about five years, mostly as a folk dancer. In the past few years I have become more involved in other FSGW activities, especially working on the last two Washington Folk Festivals. (My goal



this year is to actually see and hear some of the Festival while still working on it. Think of this as a very personal appeal to others who enjoy the Festival to come and volunteer some time during the two days!) Having eaten my share of Powdermilk Biscuits, I feel it is time for me to get more actively involved in the Folklore Society as a member of the Board, and welcome the opportunity if elected."
