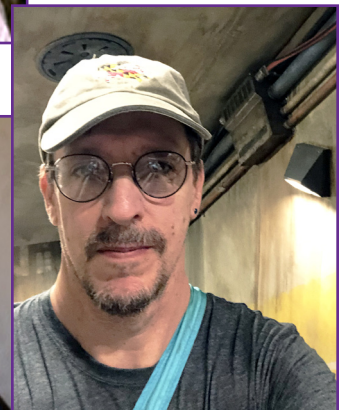

What happens when a couple of guys thoroughly immersed in folklore and traditional American music get involved with theatre? Our two performers both have so many interests and talents that they are impossible to categorize.

Dillon Bustin is a folklorist, singer, songwriter, filmmaker, and playwright.



He studied folklore at Indiana University in his younger days. Some of his songs from those times became widely sung classics—you've probably heard “More Wood” or “Shawneetown.” He found the Indiana fiddler, singer, and songwriter Lotus Dickey and brought him out of obscurity. Dillon moved east to Massachusetts and over the years started to write music for song cycles and plays based on local historical characters—folks like Joshua Slocum of Martha's Vineyard or Ralph Waldo Emerson of Concord.

Bob Lucas is a glory-shouting, sweet-singing, banjo-picking, guitar-thumping, old-time-fiddling, song-writing rounder with a desire to share a sense of musical wonder any way he can. His broad interests cover the gamut from old-time to klezmer, and in 1986, he got involved with Mad River Theater Works in Zanesfield, Ohio, and began writing songs and making plays for an ever-growing audience. His friendship with Dillon Bustin goes back decades to when they were both in Indiana, working together on the legendary Battleground Fiddler's Gathering in Lafayette

and then producing Lotus Dickey's recording. Join these two for an evening of what happens when a couple of traditional music aficionados incorporate other art formats with their music.

FSGW will not sponsor any in-person events until the community transmission rates for our local jurisdictions drops to the "low" as shown on the CDC COVID-19 Data Tracking Map (<https://covid.cdc.gov/covid-data-tracker/#county-view>).

How FSGW IS RESPONDING TO COVID-19 (CORONAVIRUS)

events with in-person attendance if the level of Community Transmission of COVID-19 is Low in the jurisdiction where the event is to be held for the 14 days prior to the event. An event will automatically be postponed or cancelled if the level of Community Transmission of COVID-19 is Moderate, Substantial or High at the time of the event.

1) FSGW sponsors three Tiers of in-person events. FSGW will indicate the COVID-19 Policy Tier in event publicity.

Tier 1: FSGW requires that participants be fully vaccinated against COVID-19. Proof of vaccination must be provided. A participant may decline to share their vaccination status, but if so, they

will not be allowed to attend the event in person.

Tier 2: Same requirements as Tier 1.

Additionally, if you are not vaccinated, you may provide proof of a Rapid COVID-19 antigen test taken within six hours of the event. Rapid COVID-19 Antigen tests are available at many clinics throughout the DMV area, and most urgent care sites. Please note that these generally require an appointment in advance. At-home tests will not be accepted. Universal masking will be required.

Tier 3: Same requirements as Tier 2 for FSGW participants. Tier 3 events occur at shared venues, where there may be individuals sharing the venue who are not following the FSGW COVID-19 policy.

2) FSGW requires that participants be registered. Attendance limits will be enforced. Preregistration is encouraged. Walk Up registrations will be accepted until the attendance limit is reached.

3) FSGW will keep a contact trace log via the registration. Name, email and a telephone number must be provided. FSGW will not keep copies of the proof of vaccination. FSGW may keep track of a participant's vaccination status.

4) FSGW requires that if a participant is feeling sick, they will stay home. Or if a participant has been exposed to someone who's been diagnosed with COVID-19 within the previous 2 weeks, they will stay home.

5) FSGW requires participants who test positive for COVID-19 within two weeks after an attended event to promptly contact the event organizer or the president of FSGW.

6) FSGW will follow the directives issued by the Federal Government, the State of Maryland, the District of Columbia, the Commonwealth of Virginia, and jurisdictions within the states of Maryland and Virginia.

7) FSGW will follow the rules established by

the venue. Events held in private residences are subject to the rules established by the event host.

8) In the event of a COVID-19 case being identified, FSGW will deliver the event contact trace log to the appropriate authority for follow up.

FSGW reserves the right to alter this policy including canceling an event as necessary.

Participant: Any person registered for or at an event. This includes audience, dancers, singers, volunteers, performers and staff.

Fully Vaccinated: A full 2 weeks after the end of a full course of a COVID-19 vaccine.

Symptoms of COVID-19: may include fever, cough, shortness of breath or difficulty breathing, fatigue, loss of smell or taste, muscle or body aches. The Delta variant symptoms may also include headache, runny nose, or sore throat.

You may see the most up-to-date text of the current policy at <https://www.fsgw.org/FSGW-covid19-response> The board recognizes that the policy will evolve as the health situation in the DMV region changes.

Some events will be hybrid with in-person and streaming participation; other events may be streaming only. Planning is ongoing for dances, concerts, the Mid-Winter Festival and the Washington Folk Festival to be in-person events. Follow the weekly e-blast and **FSGW.org** to see which events will feature in-person participation. We look forward to seeing you in-person at an event soon.
