Executive Board -- Special Meeting -- Wednesday, 18 February 1970 -- Room 710, Dupont Circle Building

The meeting was called to order at 8:30 p.m. by Vice President Mike Rivers as the President had not yet arrived.

The minutes of the regular February Board Meeting (4 February) were approved as received in the mail.

MEMBERSHIP REPORT: Joe Hickerson

As of this date, total membership is 355: 193 Individual and 162 Family. The overall increase (total memberships) is up 90 from a year ago, and up 142 from a year and a half ago. The Society is interested in gaining memberships in a relaxed way.

The Membership Chairman received a letter from the faculty adviser of the Oxon Hill (Md.) High School folk music club inquiring about a club membership. We have never had this category of membership heretofore and would have to amend the By-laws to allow for it. After discussion, a motion was made and carried that a family membership be granted the club, with a reduction of admission price at regular Society events upon presentation of proof of membership in said club. (The club will receive one copy of each publication to which members are entitled -- e.g., Newsletter, Journal. The faculty adviser will have to have his own family membership for his own family. A suggestion for the reduced admission price was 1/2 the non-member admission. The membership will be in the name of the club itself.) (Letter and reply from Joe Hickerson attached.)

PUBLICATIONS REPORT: Frank Goodwyn

The Publications Chairman expressed dissatisfaction with the duplicating service at the University of Maryland, which has been doing the Newsletter; he suggested changing to Batt Bates -- the rates are fairly comparable; furthermore, if we want a folded-over Newsletter, the University printer cannot handle it. If we reduce the General Mailing List as proposed in past meetings, 700 copies of a four-sheet folded-over newsletter would cost the same as 1700 copies of the single-sheet Newsletter we now send out.

A "Return Requested" Newsletter mailing brought 117 returned pieces -- about 1/2 of that number were new addresses, and 1/2 were address unknown and dropped from the mailing list.

In response to our free-admission offer in the Newsletter (in connection with updating the General Mailing List after April 1970), only 3-4 Newsletters were brought to the last program meeting. Our March Newsletter should note that it will be the last chance before the April cutoff to respond in some way in order to avoid being dropped from the General Mailing List.

Several Board members suggested that the Newsletter include information such as the Philadelphia Folk Song Society newsletter contains, covering events in Boston, Philadelphia, New York, etc., which would be of interest to the membership (events especially coming up, but also maybe reports on events recently past, for those who may not have had them brought to their attention but are interested in what's been going on in folklore and -music).

SPECIAL EVENTS REPORT: Bob Clayton

We lost a small amount of money on the Gordon Bok concert (31 January), due to the way in which we had to collect the admission after the Smithsonian refused to allow collection at the door. (Our agreement with the Smithsonian is on a per-time basis; we submit a new application for each use of the auditorium.) The question arises again as to the feasibility of using the Smithsonian auditorium (see discussions in previous Board meetings).

The next Special Event will be a concert on Saturday, 21 March, by the Golden Ring, including George and Gerry Armstrong, Ed and Penny Trickett, Joe and Lynn Hickerson, Sara Gray, and possibly Ruth Meyer. Bob will try to get the Ethical Society auditorium for this concert. (See also under "Old Business," below.) (This will not be the free-to-members special event November-makeup event, as considered a possibility at the January Board meeting: we need to make up for the money lost on the Gordon Bok concert.) Also: John & Ginny Dildine, Howie & Ann Mitchell.

OLD BUSINESS

According to Nancy Goland, who is a member of both the Ethical Society and the FSGW, the Ethical Society would be happy to have us use their auditorium again. Apparently the raise in rent for the auditorium was not meant to apply to FSGW and we were informed of it by mistake. John Dildine suggested that if we do use that auditorium again, we go through the Golands rather than Mrs. Pineau, and that we have some responsible member of both organizations arrange for the door to be unlocked at program time, etc.

John Jackson granted permission to Biograph Records for use of the tapes of a Buddy Moss concert. on which John played accompaniment. We received a check for \$25.00 from Arnie Caplin in response to Joe Hickerson's letter (see minutes of 6 January 1970). Caplin now wants other tapes we might have, e.g., of Skip James or John Hurt (whom we never had form a program). (Correspondence attached.)

John Dildine will again contact the National Folk Festival Association concerning payment to folk performers (see minutes of previous Board meetings and memo dated September 6, 1967, to George Simpson from Charles H. Cunningham, USDA). It has been suggested that if NFFA will not or cannot meet the payment of \$99.40, FSGW do so for the sake of the performers.

NEW BUSINESS

Trash was found in the Smithsonian auditorium the morning after our Norman Kennedy concert. We do not know whether we were responsible for its being deposited there or not since we did not check to see that the auditorium was left clean after the concert. The sergeant-at-arms should make it a point to check after every event -- we are held responsible for the condition we leave the place in even if we didn't find it clean when we came in. As a matter of diplomacy, John Dildine will write a letter of apology to Mr. Silvio Bedini, Asst. Director of Museum of History and Technology, after consultation with Ralph Rinzler to see if Ralph thinks it advisable to write such a letter. John will explain (at least to Ralph) that we found trash in the auditorium upon our arrival at a later event (Gordon Bok concert), so there is some question as to whether or not the trash after the Norman Kennedy concert was actually left by FSGW.

Vice President Mike Rivers will be away from March to September 1970. The Board appointed Frank Daspit as Acting Vice President (and Acting Sgt.-at-Arms -- see above paragraph); Frank was not present to accept or decline the appointment, so he was appointed pending acceptance.

Gus Meade and John Dildine received a call from the radio department of the Smithsonian ("Radio Smithsonian") requesting permission to tape the programs we hold in the Smithsonian auditorium, for inclusion in their radio series. It may be possible for us to have them provide us with a P.A. system, tape the programs, and give us the original tape after they have used it for their radio program, subject of course to the performer's OK in writing at the time of signing for the concert. A motion carried that John Dildine investigate this with the Smithsonian and report to the Board.

Joe Hickerson received a letter from the Annapolis Fine Arts Festival concerning their "Preview '70," to be held 18-21 June 1970, inviting participation by FSGW, for a fee. A fee of \$300.00 was mentioned: if we provided six groups, that would allow \$40 per group, \$10 for arrangements, and \$50 to FSGW treasury. A motion carried that Joe represent the FSGW and reply to the letter, asking what other kinds of acts will be included.

The Board should approve John Dildine's suggestions for a Nominating Committee by the next Board meeting (4 March). The Nominating Committee's report will be due at the April meeting. Present Board members who cannot be considered for their present positions again next year are: John Dildine, Joe Hickerson, Roni-Bowie, Bob Clayton. Joe noted that some jobs considered not to be Executive Board positions are becoming rather large -- e.g., the one of Circulation Fanager, who handles the mailing lists; such persons might be considered for at-large positions on the Executive Board (which would not require amending the By-Laws).

Getaway V: Andy Wallace has all names on a mailing list from past Getaways and will turn the list over to the Getaway Committee recently appointed. Reservations at the Getaway have always been on a first-come-first-served basis, with members receiving priority up to the deadline date. Getaway invited guests from out of town get their transportation paid and free admission.

Mike Rivers announced a going-away-to-Japan party for the Ring Shouters at Helen Schneyers on Sunday night, 22 February.

Dear Arnie,


