Executive Board Meeting - Wednesday, 4 March 1970 - Room 710, Dupont Circle Bldg.

Board members present: John Dildine, Bob Clayton, Joe Hickerson, Gus Meade, Gene Anderson, Frank Goodwyn, Kathy Goldman

Also present: Bob Banks, Kathy Clucas, Steve Winters, Lisa Winters, Joel Shimberg

Meeting was called to order by President John Dildine at 8:10 p.m.

The Secretary distributed copies of the minutes, which were accepted pending individual perusal by the Board members at their leisure. Corrections to minutes of 6 January 1970 pointed out by J. Hickerson were duly noted by Secretary, as was J. Hickerson's suggestion that Board members and non-Board members attending meetings be listed separately on the minutes.

SECRETARY'S REPORT: Kathy Goldman

The NFFA office (Room 710, Dupont Circle Bldg.) has been reserved for the Society's Board meeting on the first Wednesday of every month for the remainder of this year (through June). Miss S.G. Knott of NFFA has generously given FSGW a key to the office and written a note of welcome. Secretary will keep the key and will confirm the reservation with Miss Knott the day before each meeting, as a reminder requested by Miss Knott.

MEMBERSHIP REPORT: Joe Hickerson

A correction to minutes of 18 February: membership figures given there reflect additions since the preceding meeting, but not members dropped; therefore disregard mid-month figures on overall increase.

Total membership to date: 351; 196 Individual and 155 Family; an increase over the (accurate) figures of 4 February 1970.

Nine more "Return Requested" Newsletters have been received, mostly from far-off places.

TREASURER'S REPORT: Gene Anderson

Net worth, 31 January 1970: \$1,692.89
Income, February 1970: 180.50 (not including about \$50.00)
Expenses, February 1970: 401.86
Net worth, 28 February 1970: \$1,471.53 (not including Getaway Account)

Admissions from the Marshall Dodge program \$95.00.

J. Hickerson has received a check for \$30.00 for Getaway '69 from one Elizabeth Patterson. Bob Clayton will report on the Getaway Account at the

April Board meeting. J. Dildine suggests the Board consider taking excess money out of the Getaway Account and putting it somewhere where it would draw interest, so long as that would not interfere with FSGW's nonprefit status.

PROGRAM REPORT: Gus Meade

No report. Possible cooperative arrangement with Smithsonian Radio is still pending -- J. Dildine and Fred Gray at the Smithsonian have not been able to get together yet, but will.

Membership of FSGW is still owed one program to make up for the one cancelled in November.

The May program slot is still open. A list of performers received from Folklore Productions (Manny Greenhill) was offered as a possible source to Program Chairman.

SPECIAL EVENTS: Bob Clayton

Next Special Event will be a program by the Golden Ring, 21 March, in the Washington Ethical Society auditorium. The auditorium will cost us \$50.00 (but with or without sound system?). No further Special Events are planned until Chairman makes sure of the cost of this one, but there will probably be one in May.

PUBLICITY:

F. Goodwyn reported problems of communication with Stanley-Williams, whose Mrs. Kannelly did not notify us of the upcoming Clancy Brothers concert, which we are co-sponsoring. FSGW should not have to pay extra publicity on this event. J. Dildine will write Mrs. Kannelly stating that nothing should be placed for advertising on events we co-sponsor until we have OK'd it. The Recreation Dept.'s publication, "Do You Know," has an announcement on the Clancy Bros. concert but usually has nothing on FSGW regular programs, even though Publicity Chairman regularly sends them information on them.

K. Clucas mentioned that WETA, Channel 26, is starting FM broadcasting soon and might be a good contact for publicity; namely, the Dick Cerri Show. She presented a letter from Matthew C. Edwards, Director of Cultural Programming at WETA, which will be passed on to Publicity Chairman R. Bowie.

PUBLICATIONS: Frank Goodwyn

The Spring issue of the Journal will be finished today or tomorrow. The printing is legible, but Publications Chairman is not satisfied with the job in general. The cost will come to \$348.00. Batt Bates could print a 32-page issue for \$300.00 (approximately) -- their collating is cheaper than the

University of Maryland's (where this issue was done), but they are not cheaper on a smaller production job. The President directed the Publications Chairman to figure and report to the Board what changing to Batt Bates for Journal production would mean in terms of the overall budget.

Advertising order was received from Biograph Records (Arnie Caplin), with a request to be billed for the ad.

Suggestions were made for clarity and information in the Newsletter:

J. Hickerson suggested that FSGW events be listed first, and as such; K. Goldman suggested that the Editor put his phone number in the Newsletter (reiterating a suggestion made at a prior Board meeting), for notification of events, etc., to be put in forthcoming Newsletters; also the announcement that Board meetings are open to members of the Society and meeting in Room 710, Dupont Circle Bldg., on the first Wednesday of each month (suggested also at the January Board meeting). The openness of Board meetings and the Editor's phone number could also be announced at program meetings.

OLD BUSINESS

J. Dildine has not yet had a chance to talk to the Acting Director of NFFA concerning payment to folk performers (see the past several months) but will do so at NFFA's Board meeting at the end of the week. If NFFA is unable to make the payment, he (as President) will instruct for the Trasurer to write a check, and NFFA can reimburse FSGW if or when they can or do.

A nominating committee for next year's Executive Board was suggested, consisting of Bob Banks, Scott Odell, Gus Meade, Bob Clayton, and Michael Quitt; all were accepted by the Board. Bob Banks will chair the committee, which will report its slate to the Board at the April meeting. Nominations will be presented to (and may be presented by) the membership at the April program meeting. Some new blood would benefit the Executive Board. Ralph Rinzler was suggested for Program or Special Events chairmanship. A blackboard or easel should be available for presenting nominees' names at the April program meeting. At the election meeting (the May program meeting), ballots should be handed out at the entrance. All these are responsibilities of Nominating Committee Chairman, who also decides the point in the program at which nominations and elections should be held and conducts the meeting at that point.

J. Hickerson reported the final dispatch of the American Folklore Society's request to use FSGW mailing list for the AFS "American Folkletter master list of state and regional folklore societies (see minutes of meeting, 2 December 1969). Correspondence between AFS's Bob Byington and J. Hickerson is attached, including letter of 19 February from Hickerson to Byington sent with revised and updated FSGW membership list, stressing that the list is to be used only for mailing the American Folkletter and not to be given or sold out of AFS's hands.

NEW BUS INESS

J. Hickerson raised a question concerning the fact that although a new Executive Board is elected the second Friday in May, the officers do not become operative until 1 July. The specific issue in this instance is the possibility that Sara Gray may be bringing two performers from Scotland for a program in Philadelphia in November: Aly Bain, a fiddler in his late 20's from Shetland Islands, accompanied by Mike Whellands on guitar, baron, meuth-harp, and voice. If we want to have them for a program on the same trip, we may have to cement the arrangements in May. (Shall we write Sara to reserve them a program for FSGW the second Friday in November?) However, this is not really a problem, since the Board can pass on anything that comes up before the new Program Chairman takes over in July.

From his experience as Program Chairman, G. Meade suggested that when the chairmanship changes hands, the outgoing chairman set up or help set up the October and November programs for the next Fall.

K. Goldman relayed a request from Sarah Gertrude Knott to meet with the FSGW Executive Board, at the Board's convenience, and was instructed to invite her to the April Board Meeting. J. Dildine moved that FSGW renew its membership in NFFA (joined originally in February), at \$10.00 a year, paying dues to NFFA as token membership for use of their offices as our meeting place. The Board assented.

The Society has received a letter from the Philadelphia Folk Festival requesting the use of our mailing list for sending publicity on the PFF, with the same arrangement as they used last year, namely, sending their envelopes to Batt Bates for addressing and mailing (so that the list does not leave Batt Bates -- see discussion pertaining to AFS use of the list for American Folk-letter). A motion was made and carried that PFF again send out their literature to our mailing list, at their expense, by sending their envelopes to Batt Bates for addressing and mailing. The President instructed the Secretary to write a reply conveying this authorization and mentioning that because we are about to prune our general mailing list in April, we cannot yet tell how many envelopes they should send. Secretary should also check with Treasurer to ascertain just who did pay Batt Bates' bill last year.

Meeting adjourned at 10:00 p.m.

Dear Rhoda --

Here's a belated reply to your letter of 25 February inquiring about mailing Festival bfochures to our membership and general mailing list people. As you did last year, you can send envelopes to Batt Mates for addressing, along with a letter explaining to Batt Bates what you wish and that they should send the bill to the Philadelphia Folk Festival.

Our Executive Board discussed the matter at our March meeting. It is against our policy to send out the listing or the labels, which is why Batt Batessshould address the envelopes. However, I can't tell you the exact number to send them at the moment because we are in the process of pruning our general mailing list. We expect to complete the revision by about mid-April. The list of course will then be smaller, so if you want brochuresssent to the entire list please let us know before April 1st (or thereabouts -- I intended to write this letter a couple of weeks ago). With the unpruned list you take your chances on incorrect addresses and duplications. Our membership as of 4 March was 351; the general (nonmember) list is perhaps another 1200-1300. After mid-April we will have correct and current addresses for all those retained on the nonmember list, however many that turns out to be.

I believe I'm correct in thinking the Festival paid the bill for this mailing last year, but if I'm wrong please let me know.




