FSGW's annual camp-out-sing-in is set for October 2 through 5, 1970, at Camp 4, Prince William Forest Park, near Dumfries, Va.

As in past years, the Getaway will be a camping weekend of picking, singing, concerts, workshops, square dances, chores, eating, socializing and rain. We're scheduling the rain this year so that no one will be caught unprepared.

The campsite provides cabins and cots, dining hall and lodges for the workshops and concerts. We are limited as to the number of cots available, so get your reservations in early. The deadline is September 10, 1970. Cabin assignments will be made on a preference to society members - first come first served basis. The earliest post mark will have preference where there is a conflict. Cabin assignments, maps, words of wisdom, etc., will be mailed to all registrants. No refunds can be made after Sept. 10.

Tent camping is available if you make your own arrangements through the Prince William Forest Park. If you tent camp, you will have to provide your own eating arrangements. Saturday and Sunday activities will be open to commuters at the nominal fee of \$2.00 for adults and \$1.00 for children under 12 years. Commuters are advised to bring their own food, as none will be sold at the camp.

Your application, unfortunately, arrived too late to be accepted, and is hereby returned, along with your remittance.


Should you still wish to attend the Getaway, there are both motel and camping facilities in the immediate area. US 1, which parallels I-95, has many motels, especially in the Dumfries, Va., area, and further south, serving the Occoquan Marine Base.

Two camp sites exist in Prince William Forest Park. One is for trailers and campers, and is less than a mile from the Getaway site. The other is for tent camping, and can be reached via the main entrance to the Park at Triangle, Va., one exit south of the I-95 Dumfries exit (off I-95 at Triangle exit, west  $\frac{1}{4}$  mi. and turn right).

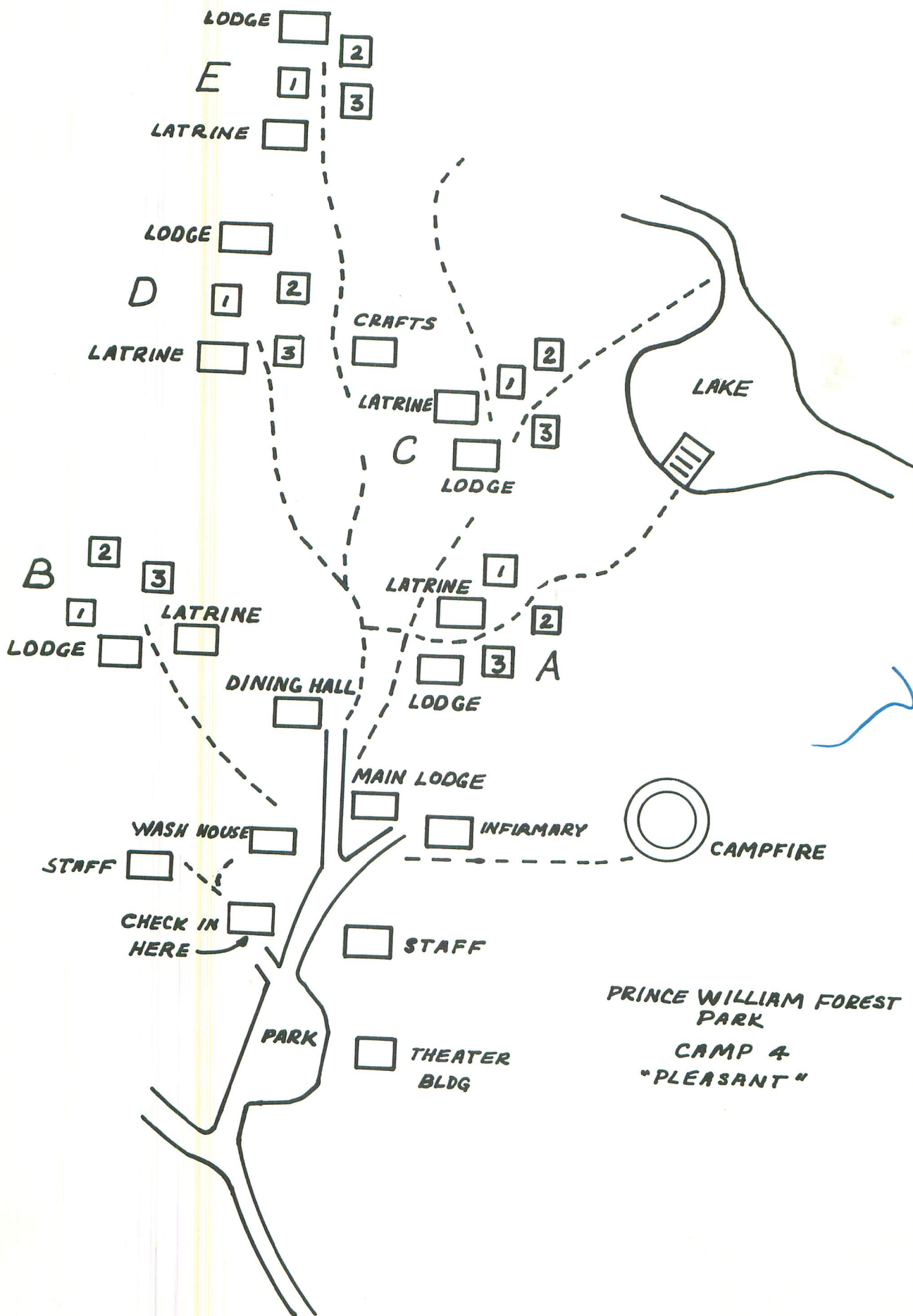
Campers, motelers, and other commuters must provide their own food, since we cannot plan for a varying number of people. Day rates at the Getaway are \$2.00 (adults) and \$1.00 (children), entitling you to the full day's activities except meals.
