#### Special Events Report: Mike Rivers

The Sampler Concert thought of for June is off since an auditorium could not be obtained for June 5, the date planned.

The annual picnic will be Sunday, June 27, rather than Saturday, June 26. It will be at Lake Accotink Park, free, and will start around 2:00 p.m. The San Francisco Folk Music Club itinerant probably won't be here for it after all.

\$113.00 was taken in at the Franklin George special re-engagement concert. (See also Treasurer's report for same information.)

The next Sacred Harp Sing will probably be June 13, Sunday, at Joel and Kathy's house in Arlington, pending a check of the calendar.

#### Publicity Report: Dick Rodgers

"Do You Know" finally listed one of our programs: Margaret MacArthur, a month late and with errors. Publicity chairman was reminded to get publicity information in to his mailing list far enough in advance to do any good, and to make sure all the facts are accurately transmitted.

#### Nominating Committee Report: Roni Bowie

An additional nomination has been received and added to the slate presented in April: Andy Wallace for Special Events chairman.

#### Tape Archive Committee Report: Kathy Goldman

Statement of policy and proposed fees for taping services to members were read and proposed agreement forms with performer and with user were distributed. Board members will study the forms and proposals and vote on forms, fees, and policy at June Board meeting.

Consideration of purchasing a tape recorder was tabled until the fall.

#### Old Business

Two difficulties were encountered in the use of the Smithsonian's Natural History auditorium. (1) At Margaret MacArthur's program, two people who came after 8:30 and before 9:00 were refused admittance by the guards at the entrance to the museum. Kathy Goldman will discuss the matter with the Smithsonian. (2) A staff member of Performing Arts attending the program on April 25 in a required official capacity (Carol Fraser) was upset by mixup over whether her husband could be admitted free or had to pay the non-member admission. (He paid half price as a result of the lack of policy on this.) The Board decided that Performing Arts spouses and family members could be admitted free, was could Performing Arts staff members working on the programs. Kathy will write a letter of apology to Carol stating also the policy henceforth, offering a refund for her husband, and requesting a list of Performing Arts staff members likely to show up for programs requesting admission. There is also the matter of Important People for whom free tickets are requested: this should not occur very often, but if it comes up again (as it did on April 25), a small number of courtesy tickets could be given to Performing Arts to use in such cases; nothing will be done or mentioned about this, however, unless the issue does come up again.

Treasurer Gene Anderson reported that a savings account at the National Bank of Maryland, home of the Society's checking account, would pay 4½% interest. A savings and loan association (e.g., Eastern Savings & Loan in D.C.) would pay 5¼% interest for 90-day accounts. Bank rates are standard throughout the area. Gene was instructed to get information from other people on various savings plans and bring the matter up for consideration at the budget meeting to be held in the summer. The By-Laws state that an account must be in an FDIC-insured bank, and savings and loan associations are insured by FSLIC rather than FDIC, but we can change the By-Laws on this point if necessary.

The plan to apply ticket stubs to a refund for a new member who joins after a program (see minutes of April meeting) could not be tried because no tickets were used at the last program. We can try the plan next time if we remember to use tickets.

The question of dividing excess profits (if any) with performers was again tabled; it could be brought up as a proposal at the budget meeting (= fiscal meeting). Mike Rivers will chair a committee to study the possibilities, combinations, and permutations, make recommendations, and/or present a proposal.

# New Business

Might Society members be interested in have a contra dance? As a special event? On a regular basis? Some might. Who would pay?

Dale Cooney (reportedly) would like to design an emblem for the Society to replace the eagle on letterhead, etc. The Board is open to suggestions. "Sounds great."

Philadelphia Folksong Society will mail publicity for the Phila. Folk Festival through Batt Bates with the same arrangement as last year. Kathy

Goldman will inform Rhoda Rosenberg at PFS that it's all OK, and Kathy Clucas will be itais on between PFS and Batt Bates. PFS will send envelopes to Batt Bates with instructions to run off mailing list but no postage and to return the envelopes to PFS for stuffing. Joe Hickerson suggested the insertion of a blurb, either by PFS or by us through Batt Bates, indicating the discount to members and reciprocal members (that's us). Kathy Goldman will find out what the membership discount is.\*\*\* We can also put a notice in our June Newsletter for members to watch for the PFS mailing and announce the discount.

Philadelphia Folksong Society's picnic is June 20 (the Sunday before ours), and FSGW is cordially invited. The cordiality was extended reciprocally in a phone conversation between Kathy Goldman and Rhoda Rosenberg, who will exchange information on where the picnics are, etc., for listing in respective newsletters.
