- 6) Dick wants to make money with the Special Events, i.e. the Jean Redpath concert. In order to do this he suggested charging \$1.50 for members and \$3.00 for non-members.

Joe suggested contacting NEMC for publicity. Debbie informed us that Dick Cerri will cooperate by playing recordings if he is supplied with them. Mandmade posters were also suggested. Announcements and flyers should be given out at the Lou Killen concert.
