

I am writing this letter at the request of the majority of the Board to express our concern and unhappiness at the manner in which you have handled your responsibilities as Special Events Chairman.

It was my impression, when we spoke together on March 8, 1976, that you felt Board members were assuming your duties as Special Events Chairman because we were dissatisfied with the number of events. We wish to make it clear that this is not the issue --- there has been no complaint at all on this matter.

Since September, 1975, the real issue has been your lack of fruitful communication with other Board members. Your job, as outlined in the By-Laws of the Society, is to:

... plan all concerts and other Special Events and ... report as detailed plans as possible, including financial estimates for each proposed event at each regular meeting of the Executive Board. [underlining mine]

Early in the Fall (September and October), when you missed two Board meetings in a row, and were inaccessible by phone, we were reluctant to do more than express concern. At that time, if you will recall, I was asked to contact you and discuss these matters by phone. You stated that you felt able to fulfill your functions and were not in need of a helping committee.

Your plans continue to be vague, and often not only conflict with Board opinion, but interfere with other Board members' performances of their jobs. The Publications editor pursues you for information;

the Publicity Chairman does the same. The confusion around your programs persists. Other Board members had to inform Sampler Concert participants that they were on the program. They had to substitute the Jug Band for the FFV String Band when the FFV informed us that they had told you that they would not be able to appear . Other Board members then had to order and balance the remainder of the performance.

We have been consistently uninformed or misinformed. The Board meeting minutes of November 4, 1975, and the February Newsletter clearly describe the Bill Steele event as a House Concert. Instead it turns out to be a full-scale concert, involving the rental of the Ethical Society Hall at an additional cost of \$75, for which you should have had prior Board approval [see By-Laws, p. 6, sect. VII:H:

The Board shall, among other powers: 1. Approve an annual budget, and all expenditures in excess of twenty-five dollars, in advance of commitment for the expense being undertaken. 2. Approve all programs and projects bearing the name of the Society, as hereinafter provided. [again, underlining mine]

The Board, in the case of the Bill Steele presentation approved neither. It is this apparent unwillingness to hear and/or respond to our concerns in any fashion that has been most troublesome. In essence, what you are saying is that through no fault of yours, the majority of other Board members are mistaken in their understanding of the situation. This we can no longer accept. It is for the above reasons that other members of the Board, when in a position to present Special Events to the membership, have moved independently of your involvement.

In two past instances, officers resigned voluntarily, when they felt unable to perform their duties. You have reiterated your ability to do your job, and yet you continue to function as if independent of the other ten Board members.
