

Minutes of Executive Board Meeting

Wednesday, January 5th, 1977

The meeting was called to order at 8:20 by President Bill Destler. Minutes were approved as corrected.

Membership: Dolores Nichols- 16 new, 21 renewals, 36 expired. Plus 3 balance for month. Membership total is 680.

Treasurer: Lars Hansling- Larry Older Concert; Fee-\$300, Travel \$252, Hall \$75. Gate \$24.

Snuffy Jenkins and Pappy Sherrill Special Event; Fee \$380, Travel \$220. Hall \$75. Gate \$278, \$50 to Publicity

Special Events: Jonathan Eberhart-March 18th Special Event will be Michael Cooney. Fee \$225, Hall \$75, charge will be \$3 for non-members and \$2 for members.

There will be a breadbaking workshop at Caroline H_oover's home on January 16th.Lorraine Lee will lead a dulcimer workshop on January 15th at Helen Schneyer's home. More ideas for food or craft workshops would be welcome. Sonia Savig may be invited for Vocal Production workshop.

If Frank Warner comes down for mini-festival he may do a house concert with no guarantee. House concert on April 14th (is a possibility) by Allistair Anderson. Charge for House concerts will be \$1.50 members and \$2.50 non-members.

Open sing on first Friday of the month will be led by Bill Destler. Topic is 'New Year Resolutions'. Tom still needs people for Feb.-June open sings.

Programs: David Olive- \$225 fee being paid to Rick and Lorraine Lee for January 14th concert. Huttons will bring the sound equipment and Bill, Mike and Mary will run it.

Magpie will do part of February program free. Fee for Rick

Schoenberg, Feb. program, will be \$150.

Motion made by Lars, seconded by Bill: The board wishes to establish a policy to not approve society members performing at the monthly programs. Motion passed, 7 for 3 against.

Any expenditure over\$25 must be approved by board.

Publicity: Nan Goland- Nan will correct misbilling for fliers. Lee record sent to HFS, underground FM radio station and AMU. There will be an article in Forecast Magazine on FSGW.

Publications: Al Kehs- Next newsletter deadline will be on January 16th. There was no program article submitted for last newsletter. Note that

Old Business: By-Law on addition of dance chairman to board was passed at previous program. Martin Holmer was appointed Dance Chairman by The Tuesday night dance group was originally FSGW Bill Destler. activity and then continued independently.
