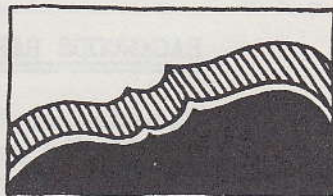

Frankie Armstrong to Appear August 2

One of those wonderful voices we've been hoping will sing for us for a long time is coming to the Ethical Society on August 2--Frankie Armstrong. She is from Cumberland, England, and has been singing the old songs most of her life. She is especially partial to British balladry, and can mesmerize an audience with her singing of "Lord Heathen." She also draws on industrial song and topical music. Some of that topical music reflects her experience as a social worker during the past 15 years with the visually handicapped, drug addicts, and as a trainer of others in her field. Frankie is a regular at folk and arts festivals in the British Isles and has toured in Canada, across Europe, and several times in this country.

Besides her concert work, she has led a number of vocal workshops designed to help singers (and non-singers) liberate their voices. Hers is surely liberated! She has recorded three solo albums and has appeared on record with other well-known performers. She will sing unaccompanied in the concert on Saturday, August 2, at the Washington Ethical Society auditorium, 7750 - 16th St., N.W. (near Kalmia Rd.), beginning at 8:30 p.m. Admission is \$3 for FSGW members and \$4 for non-members.



Bob Zentz in Concert August 12

Everybody says nothing ever happens in Washington in August. Not so! Bob Zentz is playing for FSGW on August 12 at the Ethical Society. Yes, it's a Tuesday, at 8:00 o'clock, and the kids don't have to be in school the next day. You can even bring them, because Bob will charm them as he will charm you. You can sing along on the traditional melodies and you'll probably pick up Bob's own songs after a couple of verses. They are among the most singable, and they'll come back time and again for months or more. Bob runs Ramblin' Conrad's--in fact, two of them now--in Norfolk, VA, so he's practically a neighbor. The stores deal in traditional music forms and instruments, and host Songmakers of Virginia concerts. Bob has guided the Old Dominion University Folk Festival for a number of years, and also has two records on the Folk-Legacy label. Come enjoy the air-conditioned surroundings and the comfortable, singable music of Bob Zentz on Tuesday evening, August 12, at 8 p.m. in the Washington Ethical Society auditorium, 7750 - 16th St., N.W. BACKWOODS BAND TO PLAY HERE AUGUST 23

Dulcimer fans take note! On Tuesday evening, July 22, at 8:00 o'clock p.m., there will be a house concert featuring John Molineux and Madeline MacNeil.

Maddy has a strong following, especially in Washington and the nearby Blue Ridge and Shenandoah areas. Hers is one of the clearest voices you'll ever hear sing a ballad. She accompanies herself on appalachian dulcimer and is editor of Dulcimer Players News. She lives in Winchester, VA, and has recorded several albums.

John Molineux is joining Maddy for a one-month tour, visiting from his native France. He is a sometime member of the John Renbourn Group and plays dulcimer and an instrument called a dulcichord. He has designed a foot-operated chording apparatus for a dulcimer-type instrument; the resulting sound is reminiscent of a harpsichord--but not quite. With this, he sings the old songs and plays dance music from France and the British Isles.

The concert will be in the home of Ursy Lueder in McLean, VA. It's a beautiful setting and really easy to find and get to. It's one block outside the Beltway (exit 13, route 193). Old-time southern American music is alive and well and we'll present conclusive evidence of that on Saturday, August 23, at the Ethical Society. The Backwoods Band, fresh from the Philadelphia Folk Festival, will perform in concert for FSGW with mountain songs, dance tunes, swing, and blues styles.

These are seasoned musicians, organized by Mac Benford after the Highwoods Stringband dissolved. You'll have a hard time sitting still. The group has played for dances here in recent months; now we'll get to sit back and really listen to the music. So all you old-timers and those whose music tastes stretch back to the 1920's and 30's--when stringbands swung throughout the South--come join us on this toe-tapping evening.

NEWS FROM MICHAEL COONEY

The Folklore Society recently received a couple of "gnus-letters" from Mike Cooney. Here's one of them:

Dear Friends,

This is to thank all the hundreds of people who sent cards, letters, thoughts and gifts to me during the many months since my accident and the operations which followed. I am overwhelmed by the love and support. Thank you VERY MUCH.

This is also to announce the dissolution of the Michael Cooney Trust Fund. I feel that with careful management I can get along until the fall when I will be returning to work. So far the Fund has collected \$31,000. My medical bills to date total \$20,000, and other expenses amount to \$18,000. These include living expenses, child support (7 kids), telephone calls (made by me and by others on my behalf), partial payment on another van, insurance, professional & legal fees & services, etc.

Not all of the medical bills have been paid, and I must undergo at least one more operation, but it's hoped that these will be taken care of by an insurance settlement (I had a little uninsured-motorist coverage which my insurance company has been reluctant to part with).

It is dangerous to single out individuals to thank; I feel that so many people did everything they could and more. (Just as the person who sent 85¢ and the person who sent \$1,000 each sent all they could.) Even so, I want to especially thank some long-time friends for ongoing support and help in many forms. They are, in an alphabetical order: Ed Sweeney, of Providence, R.I.; Andy Spence, of Voorheesville, N.Y.; Linda, Dave, & Anya Siglin, of Ann Arbor, Mi.; Estelle Klein, of Toronto, Ontario; Emily Friedman, of Chicago, Ill.; Jennifer Browne, of Toronto, Ontario; Michael Allison, of Foster, R.I.

It will take a lifetime to thank everyone properly. I want to answer every letter, but I find it very hard to write short letters. I'm working on 'em, though. I'm working on a lot of things. Thank you to all who made that possible.

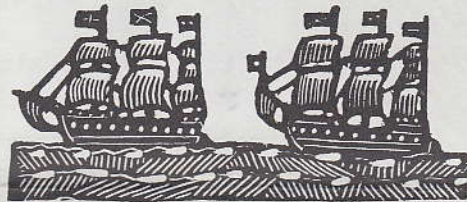

HUGILL SHANTY COLLECTION REPRINTED

Good news for sea shanty lovers! The well-known and highly regarded book Shanties from the Seven Seas, collected by Stan Hugill and first published in 1961, has at last been reprinted by Routledge and Kegan Paul, Ltd., London. This extensive collection, long out of print, is considered a definitive work in its field.

Several folks have shown interest in obtaining copies, so a group order is being coordinated. The book sells for \$30.00 per copy (it's a pretty fat book), and because of the amount involved, payment will have to be made in advance. There is a possibility (not a certainty) that we may get a slight discount.
