Publicity

Expenses will be greater if there are more special events, or increased postage & printing costs. Need estimate from Claudia of What it costs to publicize each event.

Publications
- expenses were \$6228 last year
- tentatively budgeted for \$8000 this year.

K.H. would like an extra \$700 for Kroytype machine and electric stapler.

Program - last year's expenses were income was #3740 income was # 834

Cathy proposes a budget of \$600 a month for 1981-82, which would cover:

3 solo performers @ approx. \$300 each 3 small groups @ approx. \$400-500 each 3 larger groups @ approx. \$700 each ->

Program, cont'd

Phone expenses + postage for program chairman are to come out of Publicity budget.

Dave suggested possibility of starting a special fund for transportation. Unsure how much money that would involve or if we even have it. Pat + Cathy to report on their projected needs for such a fund

Membership

income last year was approx. \$11,600 projected '81-82' income is \$12,000 (at current dues rates)

Don + Dolores have not been changing for computer time, labels, electricity. They should be reimbursed for this. Dolores to come up with estimate.

Dance

last year's expenses were 11,095 Pat hopes to expand dance activities this year to include:

- (seed money needed from FSGW for) twice a month teaching of dancing calling, dance-music-making. One evening would be English, the other American

— family dances: 4@ \$400 each.

- 10-week subscription dance series

- a dance music weekend

Pat plans to continue the Sunday night dance on a self sufficient basis.

Dave has not had time to dissect last year's books, but based on what he knows now:

total projected income (excluding Getaway) for 1981-82 is

1812,000 projected Getaway income is \$2,000 present net worth is around \$13,000 Total projected expenses for 1981-82 are \$21,150

GRAND TOTAL (estimate) is + \$a7,000 - \$a1,150

This is not a large margin and depends on K.C.'s events consistently breaking even or making money. If they don't, we could be in trouble.

David will recommend restraint in special events programming and/or a dues increase.
