## unorganized reflections: A

There was some overordering (for the ~~o~~ beef soup & the red tomato sauce). These mistakes can be avoided next year by a more careful increasing of recipes or a more logical expectation of number of people. Nevertheless the amount of cooked food left over was in line with amounts I saw the past two years and the cooks said that in general there was much less left over than last year. (The cooks I figure are excellent judges - they have been the only human kitchen constants over the past ten years.) The cooks liked this new kitchen (camp #2) much better than the old one (#4): it has a good grill and food was stored in the kitchen not many needless steps away in a pantry; plus it was just laid out better. They felt it was a very pleasant, relaxed weekend (much more so than some years) for them. ~~The~~ Milk was not delivered (whether the error was on the milk company's part or our part I don't know) so trips were made for it. A tiny bit of Pete's stuff got used early on and had to be replaced (the cooks actually had separated all his stuff early on so it would not be used). The cooks were extremely pleased that I had sent them a copy of the recipes as well as of the menu and proposed volunteer schedule/kitchen

work schedule weeks before the Get-a-way.

I believe a good final inventory was taken. When I get it I will collate it with what came in as a guide for ordering next year.

I followed last year's limited inventory and still ended up with too much bread, too little large juice cans (so we used a case and a half of the little cans), and ran out of hot chocolate on Saturday night (last year was warmer than this year).

Dick Rogers is trying hard to find a complaint about the menu but hasn't found one yet. Since I have heard no complaints people are being either extremely polite (which would shock me) or the food went over well.

I also bought ~~some~~ some pired coffee creamer this year. I did not get potato chips.

I was never given firm budget guide lines. I garnered some figures from ~~notes~~ last year's notes, received no figures from the Treasurer, and was told repeatedly by others to just do it. So the cost is ~~so~~ more than last year's (I finally saw a rough 1980 total figure 3 days before the get-a-way) but inflation may account for most of it. Plus some of the paper goods were bought with the idea of selling them to Halloween and mine and their cost should not really be attributed

to the Get-a-way (cups for instance - too many were delivered but I accepted them ~~so~~ because of the min, etc). When I have a final inventory in hand I will compute the minimum paper goods cost which should be passed on.
