NEW AND EXPANDING ROLES: Winters moved that the Board appoint a committee to guide and develop educational programs for FSGW, and that among its responsibilities this committee should as a high priority make available interpretive materials to accompany major programs and concerts. In addition the committee should pursue as appropriate:

1) having workshops/demonstrations at FSGW events; 2) more master classes given by those who perform at our events; 3) one-shot introductory classes, eg. "this is what Appalachian music is about"; 4) be a clearing house for educational services in folk lore, arts, music, crafts, etc; 5) series classes eg. how to play the guitar; 6) interpretive and educational material to be handed out at concerts and programs (about that event). There is a need to get more information about what services people would like and what services are available from other sources. We should not duplicate services available elsewhere. Woods 2nd. PASSED. An amendment was made by McCracken to preclude FSGW educational programs from becoming directly involved in public schools. Fitterer 2nd. LOST.

LARGE SCALE EVENTS: Fitterermoved that it be FSGW policy that we have no prohibitions against programing large scale events such as major concerts. Woods 2nd. PASSED. Winters moved that the President appoint an individual to form a committee to explore the consideration, preparations, and consequences of doing large scale events. Woods 2nd. PASSED.

NEW PROGRAM AREAS: A number of suggestions were made including: 1) dhildren's concert series; 2) family and/or children's dance; 3)educational tours; 4) festival tours (ie. arrangements for transportation to festivals); 5) more craft related functions such as quilting bee, barn raising, bread baking; 7) ethnic foods series; 8) co-sponsored events such as at nursing homes; 9) shopping center concerts; 10) social events such as parties, caroling, and pot-lucks.

ARCHIVES: Fitterer moved that the functions of the FSGW archive should include as its first priority the complete and accessible documentation fo FSGW activities. Further, that its long term goal shall be and archival record of all folklore related activities in the greater Washington area, and that to implement these goals an archive committee shou should be formed to be chaired by Bill Day and that this committee shall identify what materials we should be saving in the archive and then set up a general plan for collecting and filing that material. In addition the Board should establish a finance com committee whose task is to draw up a five-year plan based on the Finance section in the notice for this meeting. The finance committee should also reccommend a reserve fund formula. Olive 2nd. PASSED.
