FSGW BOARD MEETING AUGUST 3, 1983

BOARD PRESENT: Hickerson, Olive, Nichols, Day, Cliff, Clayton, Woods, Kraemer, Lingard, Lite, Bryant

BOARD ABSENT: Hamlet, Goland, Turner, Winters

OTHERS: Dean Clamons, Dolores Nichols, Mike Rivers, Linda Leiberman

The meeting was called to order at the home of Kathy Hickerson at 8:10.

The minutes were approved.

MEMBERSHIP: 54 new + 117 renewals = 171 - 135 expirations = 36.Total: 2031 members. Wants to order envelopes with return address; 2.000 for \$441.40, to be paid in advance. Woods moved, Clayton PASSED. seconded.

PROGRAM: The Sept. 9 program will be Kubanakan, an Afro-Cuban group. The rest of the year is pretty well set, but as contracts have not been signed and returned yet, names will not be officially

announced.

SPECIAL EVENTS: The cowboy concert, co-sponsored by FSGW and the American Folklife Center, presented some problems. First, the American Folklife Center did not make any announcements. No mention was made of the fact that Patsy Montana was not there, or of who was performing. Second, FSGW had to pay \$150 to rent sound equipment adequate for the hall at Eastern Market, which involved a lot of work by Mike Rivers. The Library of Congress had paid for instrument amplifiers, but FSGW had to expand. The house concert with Nick Plakias netted \$68 to Nick, \$0 to FSGW. The Eric Bogle concert was very well attended: 320 people. Bogle earned \$850, and FSGW cleared \$350. Expenses: \$83.19 for chairs, \$75 for the hall. The schedule for Sept.-Dec. is well set and is being kept with the minutes. HALLS: The Bradley Hills Presbyterian Church, on Bradley Blvd. in Bethesda, will be used for three concerts in Sept. & Oct.; it has good parking, is on a bus line, has "wonderful" acoustics, air-conditioning, a built in recording system, and seats 550 (475 in the center section) on padded pews. The Hall will be free for these three concerts; the \$150 fee is waived for non-profit groups and those with "redeeming social values". Also discussed the Gunston Arts Center, near Arlington Ridge Rd. in Arlington. Seats 625; wants co-sponsorship and a fixed fee of \$200. Advantages: they have a sound system with an 8-channel mixer, speakers, and mikes, and a newsletter and mailing list. Disadvantages: it's expensive, would we be able to control the sound?, and double publicity could be confusing. Family concert series: Clayton talked to Mike Dover at the Waldorf School in Bethesda. Since the faculty has to approve any concerts, no arrangements can be made until Sept.

PUBLICATIONS: The deadline is Aug. 15; mailing in Aug. 25.

PUBLICITY: Hickerson needs pictures and info within a week for Daglish & McKenna. Ordered and received 2,000 stamped, return-addressed envelopes, to be distributed to publicity, special events, etc. DANCE: No replacement hall yet. Will recontact Takoma Park Jr. High

to use on a month-to-month basis until a better hall is located. Discussed our relationship to CDSS (Country Dance & Song Society). Lingard feels that the by-laws and constitution of CDSS represents many of the same goals and objectives as FSGW, and she would like to see FSGW maintain center status at a cost of \$25/year. Advantages: resale on consignment of records, books, & small instruments, local mailing list is available, with computerized mailing labels, a 40% discount on film rentals, and info available for the cost of copying. If our members join CDSS, they receive a \$2 discount.

FSGW has been a member of CDSS for about 8 years, and got center status about 4 years ago. Woods moved to maintain center membership status with CDSS. Olive seconded. PASSED. Clayton moved that FSGW not grant admission discounts to CDSS members. Cliff seconded. PASSED. An article in the newsletter will point out the existance of CDSS and the benefits of our membership in it.

WFF: Clamons has a list of names for people to replace Winters on the coordinating committee. A name will be brought to the Board for

approval in Sept.

FINANCE COMMITTEE: An idea meeting will be held Sept. 6 at 8 pm at the

home of David Olive, 517 Ingraham St. NE.

GETAWAY: Applications will be in the September newsletter, and will ask about dietary restrictions. It was suggested that the registration form should ask about smoking/non-smoking. 32 invitee letters

were sent out, with 2 acceptances so far.

ARCHIVES: Day will develop guidelines, procedures, and recommendations as to how to maintain the archives, and will present such to the Board in Sept. As of now, Day believes that all materials other than copies of tapes, currently being held at the home of Mike Rivers, should be in the archives. All photos and negatives should be eventually retrieved from the home of the photographer where they have been kept. The sound equipment has been moved to Day's home to enable archive workers to have more room to set up and organize, Hickerson wants an article in the newsletter and notes to past presidents asking for materials. Glen Echo will need access to the archives in case of major electrical problems. All keys must be carefully accounted for.

COMMUNITY OUTREACH: Leiberman has requested info and a list of signers from Mia Gardiner. Hickerson would also like to have a list & info. The procedure for getting a signer for a performer is as follows: 1) Clear the idea with the performer. 2) Contact Leiberman, more than 2 weeks before the performance. 3) Ask for a specific person

if desired.

BUDGET: Three options were presented to the Board; low, medium, and high options. Attention was focused and discussion centered on the medium option. Program expenses were increased due to higher guarantees and travel costs. For the first time, WFF was budgeted to lose \$1,000. Olive suggested an increase in membership fees in order to add more of a reserve to the treasury; this will be discussed at the Oct.meeting. Clayton moved to approve the budget, Woods seconded. PASSED. A complete copy will be sent with the minutes. Total Income: \$83,400. Total expenses: \$80,650. Net: \$2,750.

SIGNER'S AGREEMENT: There was a lot of discussion on the necessity of signers working only with the agreement of the performers. It was decided that signers did not need to have the performers' addresses and phone numbers. With that info taken out of the agreement, Lingard moved that the agreement be accepted. Woods seconded. PASSED.

SALES TAX EXEMPTIONS: Olive reported that D.C. requires 8 or 9 pieces of info.

WASHINGTON REVELS: No new info.

MINI-FESTIVAL SITES: Cliff reported that George Mason University Law Center will be carpeted before Sept; therefore, another site is needed. With a target date of Jan. 28, Cliff was given authority to reserve a site by the Sept. meeting.

VANGUARD BILLING: The problem was straightened up and a credit memo

was sent.

20th ANNIVERSARY: A special Board Meeting will be held on Sunday, Sept. 18, from 2-4:30 at Hickerson's home, to generate ideas. A decision will be made at the Oct. Board meeting as to the direction and leadership of the celebration.

NEW BUSINESS: There was a lot of discussion of the policy of providing copies of tapes of performances to members. The policy has been for Mike Rivers, who maintains the tape library, to provide tapes for \$5 at members' requests. Questions brought up were whether or not performers should be given royalties, FSGW should make a profit, and Mike Rivers be paid for his labor. Cliff moved that the fee for taped copies of concerts would include payment to performers, tape cost, and the labor for the tape copy, to begin Sept. 1, 1983. Woods seconded. PASSED. Mike Rivers will come up with a fee by the next meeting. An article in the newsletter will remind members that taping at performances is not allowed, and that the price of concert tapes will be increased. Signed performer forms giving permission for tapes to be sold should be kept in the tape box. Co-Sponsorship: Mike Rivers would like to see policies developed regarding co-sponsorship. There have been problems of defining responsibilities in recent events. Two examples are the cowboy concert on July 21, and the Libba Cotton concert, co-sponsored with the Smithsonian, in March. Rivers stated that we should let other organizations know that FSGW is available for co-sponsorship, but that there should be a clearly defined policy and written confirmation of responsibilities. All co-sponsored events should be arranged in writing in a businesslike manner. Cliff and Clayton will work on a checklist to be used in a cover letter. Out-of Town Memberships: Olive moved to raise the cost of newsletters to out-of-town subscribers to \$6. Woods seconded. PASSED. A statement in the newsletter will state that this does not include any membership benefits. D.C. Space suggested that FSGW sponsor a folk music or open stage there on Mon. or Tues. evenings. Special Events will investigate and report back in Sept.

The meeting was adjourned at 11:35 pm. The Sept. meeting will be held

on Sept. 14 at the home of Woods and Clayton.

MOTIONS PASSED FSGW BOARD MEETING August 3, 1983

- 1. To maintain center membership status with the Country Dance & Song Society, at an annual cost of \$25. FSGW will NOT grant admissions discounts to CDSS members.
- 2. To approve the medium option of the budget presented by the Treasurer.
- 3. To accept the proposed signer's agreement, with the stipulation that first clearance be obtained from the performer(s).
- 4. To set a new fee for the taped copies of concerts. This fee will include payment to performers, tape cost, and the labor for the tape copy, and will become effective on 9/1/83.
- 5. To raise the cost of newsletters to out-of-town subscribers to \$6/year.
