BOARD MEETING

September 5, 1984

BOARD PRESENT: Hickerson, Nichols, Bluestein, Winters, Eisner,

The meeting was called to order at 8:10 at the home of Dave Eisner. The August minutes were approved.

REGULAR REPORTS:

MEMBERSHIP: 57 new + 81 renewals = 138 - 78 expira. = +60. Total; 2230

PROGRAM: Bluestein reported that the September program would be Arlene Mills and her gospel group. There would be no October program because of the Getaway, and the Nov. 9 program would be Bodie Wagner. There has been some problem with keys not working at WES. Bluestein said he would be talking to someone there about it.

SPECIAL EVENTS: Clayton announced that the Mini-Festival would be run by Dave Olive and Linda Lieberman, and would most probably be at Trinity College on Jan. 26. There will be a house concert/ storytelling at the Hickerson's either right before or after the Getaway, with Maggi Pierce. There is no hall yet for Bok on 11/10. There was a letter from Cathy Fink regarding the admission for the Judy Small house concert. She felt that members should pay \$4, and non-members \$5. Clayton felt that he didn't want to raise all the prices at once, and Schlesinger agreed. There was a strong feeling that that there should be one price for all house concerts, so that there is no value judgement on the worth of a performer. Bluestein moved that we change the admission of future house concerts to \$4/\$5. Winters seconded. 6 in favor, 3 opposed. PASSED. Rich Kirby and Tom Plebsoe will be performing in December. A 20th Anniversary party is in the planning stages for Nov. 17 at Trinity; Mary Cliff is looking into it. There have been some verbal agreements by performers Kathy Barton and Ed Trickett for Jan., and Sally Rogers for Feb., and Daglish/Larsen in March, but Clayton is reluctant to repeat too many performers from last year. TREASURER: All the information requested by the IRS has been submitted

by Dave Olive. He was required to send newsletters, information on Special Events, the By-Laws, lists of names and addresses of Board members of the year in question. Clamons reported through Hickerson that when we raised the dues last month, we did not vote on fees for out-of-town subscriptions, or on contributing, sustaining, or life memberships. Clamons proposed the following dues increase:

DANCE: Eisner reported that the Sunday night dances start this Sunday. October 20 will be a West Coast Swing group. T-shirts are being printed, and will be sold for \$6 members/\$7 non.

Some big dances are being scheduled. Sunday, Jan. 6 will be Kevin Burke as fiddler, with Ruth Rappaport on the piano and Bridget Edwards calling. Jan. 13 will probably be a double-header, with two groups performing at 3:00, then a dinner break, and the two groups coming back. Dave is trying to set up a dance and concert with Trapezoid and John McCutcheon on Dec. 9, but for various reasons the negotiations on that are delicate. Eisner raised the issue of the janitor at Takoma Park Junior High working past 11, but getting paid only from 7-11. We agreed with Dave's paying the janitor the \$12 more he should get to clean up past the closing time of 11:00. We now will pay \$67 instead of \$55.

PUBLICATIONS:

No report.

PUBLICITY:

Hickerson stated that the publicity had gone out for the Sept. program on time, and that the publicity for Kinvara had been very good. There were a few lines in the paper before the concert, and a review after. Unfortunately, the review didnot mention FSGW. The AAA called, and wanted to include Caroling through the Metro on their December calendar. Thus, the date was set for Dec. 22. Hickerson also mentioned the WFF to the AAA, and they said that it would also be featured.

COMMITTEES: WFF - No report. 20th Anniversary - There is a possibility for an all night party at Trinity College on Nov. 17. The Glen Echo series in October needs to be publicized. Getaway - Dolorès Nichols reported that Maggi Pierce and those invitees mentioned in the newsletter are coming. We could accommodate up to 320, but hope for 270. The next meeting will be Sept. 18 at Joanne's. Finance: Dave Olive and Mary Cliff are interested in being involved in this committee. Sound/Lighting: Winters reported that at the first opportunity at Bradley Hills, he would like to set up an hour early and experiment with sound. Community Outreach: No report.

OLD BUSINESS: Incorporation: The papers have been officially signed, sealed, and delivered. They will be kept at the home of the Secretary, and a copy will be sent to the Treasurer and the Archivist. A letter from Attorney Sanchez to the IRS informed The IRS that FSGW is now incorporated. Sanchez's office will take care of the necessary reporting process for incorporation. Survey of Performing Members: Dolores reported that she had mailed 190 questionnaires by Aug. 20, and she has received 61 replies so far. This is a better response than ever before received from any questionnaire, and the responses have been interesting. She has been giving Dave Olive the data on people for the Folk Services Directory. Folk Services Directory: Hickerson was reporting for Olive. There will be a formal proposal to the Board for money to send out a list to people, and then to compile the list. There will be numbers available next month. There was a feeling it should be sold at a discount to members, and should include classifed ads and display ads for a fee. <u>Guidelines for Cosponsored Events:</u> No report.
