REGULAR REPORTS:

MEMBERSHIP: 56 new + 74 renewal - 171 expiration = -41. Total: 2198 PROGRAM: Bluestein reported that there were about 100 people at the Bodie Wagner concert, 15 of whom were non-members. There were two issues that came up at the program that Joel wanted the Board to discuss; picture taking and television cameras at Photographers at concerts: This issue arose because a member wanted to take non-flash pictures at the concert. following policy will be reiterated in the newsletter: There will be no flash pictures at FSGW events, and FSGW reserves right to restrict activities such as photography that might be disruptive to the audience or to the performer(s). It was felt that the producer should be the contact through which any permission to photograph was granted, and that the producer would get the prior permission of the performer. TV Cameras: There is no official policy on TV cameras; it was generally felt that we must always try\*balance accommodating the media while also respecting the audience and the performer. Some members of the audience will always protest, but the benefits of the publicity outweigh the little bit of flack we might get. If possible, the publicity chair should take care of the crew while the producer takes care of the performer. GETAWAY REPORT: The wrap -up meeting conceluded that the Getaway had been successful. Some recommendations: We need to work on the dance program more, since the Getaway is one of the few events at which the dance and non-dance factions of the Society can mix. Our list of invitees did not include any dancers, callers, dance musicians except Bob Walser. The Friday night dance roughly broke even, but was not really well advertised and was pitted against a couple of other dances. The committee couldn't decide whether to pay Dave Laning for his efforts with food. Clamons suggested that this should be decided on a case by case basis and not be a matter of policy. Finally, the co-chairs recommended that things start a little earlier next year, so that more information can go into the summer newsletter. We made about \$400 on the Getaway, with an attendance of nearly 200. Clamons has talked to Camp Letts about next year's Getaway. We have reserved Columbus Day Weekend. The cost is likely to be about 6% higher, up to about \$6000. Clamons feels that we can keep the same price structure, but should try to up the attendance by 10%. He specifically discussed some of our problems this year. They agreed that exclusive usage means exclusive. They also understand that we expect them to staff the water-front and horse stables for our use. Any discussion with the camp should be with Pat Butcher or Tom Hall, and agreements should be written down. (This report was taken mostly verbatim from a report written to Kathy Hickerson by Dean Clamons, and read at the December Board meeting.)
