Treasurer's Report:

- Stats and new budget new fiscal year just started September 1st....new QuickBooks accounting system is in place. Fortunate to have Leslie Barkley as our accountant. Just send her the data by e-mail and then follow the e-mail up by sending the hard copy backup to her. It is vital that we stay on top of all financial matters. Leslie knows how to file our non-profit tax returns, is efficient, and has the right ideas about preparing us to be audited so that we can become eligible for United Way funding.

- We will have a new door sheet to be used at all FSGW events.
- Mary has come up with an envelope system which will matchup specific programs with an envelope in the cash box so that we can always track for which event particular funds are related.
- Can we add outreach category? Jerry says yes we can add this category.
- Insurance and Board Liability Cultural Alliance of Greater Washington ("CAGW") says we ought to have the list as to what our Directors and officers Insurance covers. Jerry is requesting a quote.
- \$1,800 refund on an insurance premium that was never claimed has been reclaimed due to investigative work done by and information shared by Tom Spilsbury.
