## **President's Report:**

• Lucia attended the GEPPAC gala along with 7 other FSGW-linked folks. It was a lovely event to support Glen Echo Park.

## **Treasurer's Report:**

- To date this fiscal year, there is a net loss of \$22,567. The approved budget was for a loss of \$29,174.
- Bruce Edwards was added as a signatory to the Dance account, and will be getting a deposit card for the Main account.
- The second Getaway deposit, \$8100, will be due June 1; the Wild Apricot Annual Fee, approximately \$12,200 will be due June 30.
- Jackie renewed insurance with CDSS for all of our venues. Jackie is working to make sure all venues that are used for FSGW events are under our insurance. This does not include house concerts.

#### **Dance Report:**

- May Dances:
  - o Family dance, Silver Spring contra, weekly ECD as per usual.
  - ECD Ball May 17: No financial report yet but it was well attended with over 100 tickets sold. This should be well above the break-even point. Very successful event and next year's chair is already at work.
- Upcoming Dances:
  - o Family dance: June 8. Jacob Barker calling to Katie Stalh and William Brauneis. We can no longer have the dance at Browne Academy. It will move it back to a double classroom at Glen Echo Park.
  - o Silver Spring Contra: June 12 Janine Smith calling to Frog Hammer in the Great Hall.
- Laura expects to hand off duties to the incoming dance chair by the end of June.

## **Program/Concert Report:**

- Trio Sefardi concert happened this month at Washington Ethical Society. It was an artistic success but not a financial one. 65 people attended but the venue cost was high. If Betsy can't negotiate a better rate, we will not host more concerts there.
- Upcoming concerts:
  - o June 12 Keith Murphy and Yann Falquet at Stephanie Kaufman's house.
  - September 6 Alex Cummings and Audrey Jaber house concert at Jamie and Betsy Platt's house.
  - o Brian Dolphin & Elizabeth LaPrelle finalizing September date
  - o Patrick Egan & Seamus Wade house concert finalizing October date
- Seeker's Church has offered us a good venue rate. We will likely host a series there.
- Old Parish House in College Park is interested in having us host more concerts there. We've had one successful event there so far.

## **Office Report:**

• Mo and Milo introduced themselves to the incoming board members and provided an overview of what they do for FSGW.

### **Webmaster Report:**

- Will is leaving the position of webmaster and moving away from the area sometime around September 2025. Will documented all the tasks he's done for many years.

#### **Newsletter Advertisement Policy:**

- The way the policy is currently described is oriented towards a print edition newsletter.

There is a difference between listings and advertisements; this needs to be reflected in our policy. Historically it's been at the newsletter editor's discretion to include larger graphics.

## **Support for Board Members:**

# New Series: Queer-affirming social dance in Alexandria

- Milo and Lucia are working to start a new dance series. Milo did a lot of venue hunting and proposes the Durant Center in Alexandria. It has many positive attributes including being accessible by public transit.
- Lucia has offered to call the first dance for free.
- There are still many details to be decided including the type of social dance and the frequency. The goal is to have the first dance in September 2025.
