Hot Mud Family to Perform July 23

On Friday, July 23, FSGW will present a performance by a fine Midwestern band, the Hot Mud Family, whose many moods and tempos are sure to provide a toe-tapping summer evening's entertainment. A long-lived group, whose core has been together for ten years, the Hot Mud Family plays mountain ballads, Carter Family songs, old-time stringband tunes, Jimmy Rodgers songs, bluegrass, gospel, and country songs. They combine the rhythmic lilt and instrumental sensitivity of old-timey bands with the expressive vocal technique and finesse in harmony singing common to bluegrass music.

Together and individually their playing is superb. Dave Edmundson is an inventive old-time fiddler, mandolin player, and vocalist. Suzanne Edmundson, sometime lead singer, also plays guitar, clawhammer banjo, and piano. Rich Good sings and plays guitar and banjo; Gary Hopkins sings and plays a masterful bass; and Greg Dearth is a red-hot and comfortable fiddler. Together, they pour forth a torrent of good feelings.

Songwriter Eric Bogle Here Aug. 20

Scottish-born songwriter and singer Eric Bogle, along with guitarist John Munro, will present a concert for FSGW on Friday, August 20. Bogle is best known as an insightful



songwriter, whose original songs are both powerful and evocative. "The Band Played Waltzing Matilda" and "No Man's Land" are among Bogle's many fine songs; to date, twelve of his songs have been recorded by nearly 40 different singers. Besides being a songwriter, Bogle is a fine singer and guitarist, singing many traditional songs of his adopted home, Australia, along with his original material.

Joining Bogle will be John Munro, another Scottish-born emigrant to Australia. Munro's work with mandolin and Celtic guitar has won him many prizes; he has played on more than a dozen albums. He is a perfect foil for Bogle's singing, reinforcing and complementing the lyrics, but never intruding.

Bluestein Family in House Concert August 28



On Saturday, August 28, the Bluestein Family will bring the sounds of traditional American family music to a house concert for FSGW at the home of Margaret Foster in Bethesda. Although the Bluesteins have been performing for eight years in their home state of California, this will be their first Washington appearance. The family group includes Gene Bluestein and his four children: Evo, Jemmy, Frayda, and Joel (currently a D.C. resident). The group's repertoire includes a broad cross-section of the styles which have contributed to American traditional music. These range from the music of the Carter Family and Southern stringbands to French-Canadian, Cajun, blues, and contemporary music in traditional styles. The Bluesteins perform on banjo, fiddle, guitar, mandolin, autoharp, tin whistle, accordian, and dulcimer. The family members have recorded five albums of their own, and also appear on Jean Ritchie's album, High Hills and Mountains. BOARD MEETING HIGHLIGHTS

The FSGW Board met Wednesday, June 2, at the home of Mary Cliff, and on Wednesday, July 7, at the home of Joanne Turner. Among the Board's major actions at those meetings were:

• A decision to spend considerable time evaluating FSGW's current role and possible future directions (see story below);

• Approval of a motion that treasurer David Olive deposit approximately \$6000 currently in an FSGW savings account in an insured, 14%-interest money market fund at Government Services Federal Savings and Loan; and

• Approval of a motion to appoint Dean Clamons as the replacement for Jonathan Eberhart on the Washington Folk Festival Coordinating Committee for 1983.

FUTURE DIRECTIONS FOR FSGW

At its July meeting, the Board developed a working list of some major issues that should be discussed further as FSGW plans for its future. Among the areas identified as important were:

FSGW relations with--and service to--the Washington community. This area includes maintaining ongoing relations with area ethnic groups, utilizing the expertise of area folklorists, making FSGW events accessible to the handicapped and deaf, and working in cooperating with other community agencies.

FSGW programs and services for its members. Within this area, topics identified include possible expansion of FSGW's publications program to a larger newsletter or a newsletter and a journal, looking at ways to utilize FSGW's performing members, maintaining contact with an everexpanding membership, encouraging family participation in FSGW activities, and fulfilling FSGW's purpose of preserving and promoting traditional folk arts.

FSGW's organizational needs. Topics include dealing with membership growth, functioning as a concert-promoting agency (if that's what we want to be), utilizing volunteers more effectively, serving different geographical locations within metropolitan D.C., and distributing the burden of FSGW management.

Attention all lovers of good music, dance, crafts, and general fun. The 18th annual FSGW Getaway will take place Friday through Sunday, September 24-26. This year we will be at a new location, YMCA Camp Letts, located on a peninsula one mile from the Chesapeake Bay in Edgewater, MD. The camp provides cabins that sleep 12 people apiece. Cabins are equipped with beds and mattresses; you must bring bedding or sleeping bags. Also don't forget warm clothes, rain gear, and bathing suits.

Activities will begin on Friday night with a potluck supper followed by a dance (Bob Dalsemer calling), a sing, and children's activities. On Saturday and Sunday, there will be workshops on music, dance, and crafts during the day. Each evening's dinner will be followed by a concert and sing. Saturday night there will be a second dance. In addition to these planned activities, the camp offers canoes, sailboats, tennis, horseback riding, and a swimming pool. (Some of these involve a slight additional charge.)

Unfortunately, for the first time in at least three years, we have had to raise the Getaway registration fee, but we have kept it as low as possible to cover costs. The entire weekend, including meals, will cost \$18.00 for children 2-14 years of age and \$33.00 for all those over 14. There is no charge for children under 2.

FSGW members will get preference until September 1. After that, the remaining spaces will be filled on a first come, first served basis. Payment in full must accompany your application. This year, chores will not be an obligation, but we hope that many of you will volunteer to help at some time during the weekend. There will be a sign-up sheet at the camp.

Many of the rules will be the same as previous years, including no pets and no alcoholic beverages allowed. Because of the large amounts of waterfront area at the camp, parents with small children should be prepared to take extra care.

If you plan to come as a day registrant for Saturday, Sunday, or both, admission will be \$5.00 per day for adults and \$2.50 per day for children 2-14. Day registration does not entitle you to meals or a cabin space. The day registration form will be in the next Newsletter, or you can come to Camp Letts for the day and pay when you arrive.
